Sub: Blacklisting of your Firm namely M/s Umesh Kumar Singh.

Dear Sir,

You were put to clear notice vide show cause notice dated 06.02.2023 contained in letter no. C.E/04(S.) Part XI/111 whereby you had been afforded with due opportunity to submit your explanation within the given period with regards to details furnished by you in your affidavit dated 24.09.2019 & 02.05.2022 in a tender process which is hereunder:-

- (i) The salary details of the afore named staff /person/employees, including their proof of employment with your firm since the date of their joining in your firm as also their respective bank details showing payment of salary and their PAN Card along with TDS certificate;
- (ii) Details of contribution made in terms with PF and ESI of the labours/employees engaged by you;
- (iii) Their address and identity cards, along with their Aadhar Cards in order to ascertain their whereabouts;
- (iv) List of labours and other staff engaged in your firm for the last Seven years along with their EPF and ESI contribution.

We received your reply on 20.02.2023. At the very outset it is conveyed that your reply contains vague, confusing & misleading statements which are outrightly denied and disputed and it is unexpected and surprising from your part to make such misleading and false statements.

It is denied and disputed that you have received in-complete letter contained in show cause notice dated 06.02.2023.

In your reply you have failed to furnish the required/necessary details/document as mentioned in your affidavit dated 24.09.2019 & 02-05-2022, which clearly indicates that you have got nothing to say with regard to the same.

Instead of replying/furnishing the documents sought for from you in the show cause notice dated 06.02.2023 contained in letter no. C.E/04(S.) Part XI/111 you have tried to divert the issue/contents on false and fictitious grounds.

In such view of matter, it is thus apparent that you have got nothing to say. The details furnished by you in your affidavit dated 24.09.2019 & 02.05.2022 are false and fictitious with the primary object to be declared successful in tender process on false and frivolous documents.

In the light of the aforesaid it is therefore decided to forfeit your earnest money and security deposit & blacklist your firm for a period of five years with immediate effect.
